1. Welcome and apologies (LyS)

2. Background

LS introduced the background to the meeting and the reasoning for the proposed changes to the Article of Association for The Stove Network, and explained the purpose of the meeting to discuss and vote on the motion:

"That the Articles of Association in the form annexed and initialled by a director of the Company for the purposes of identification be adopted as the Articles of Association of the Company in substitution for and to the exclusion of the existing Articles of Association of the Company."

3. Discussion:

SJ – children's law changes during summer 2024 (This landmark legislation ensures that all children and young people in Scotland, under the age of 18, have their rights protected.). Suggestion to develop a specific policy for The Stove to incorporate the rights of children into the workings of the organisation.

SJ – Clause 6.2.1 – suggestion to add 'game design' to the list of creative activities promoted by The Stove consensus was that this was covered by phrase 'all other artform' but that we should add this term on the next occasion that the Articles are amended rather than make another change now solely on this basis

JMcB – expressed her opinion that the proposed changes to the Articles of Association had been communicated very clearly to members and made good sense. This comment was echoed by CR.

MB – reports positive responses from members to communications about the proposed changes to Articles of Association

4.Vote:

"That the Articles of Association in the form annexed and initialled by a director of the Company for the purposes of identification be adopted as the Articles of Association of the Company in substitution for and to the exclusion of the existing Articles of Association of the Company."
